## **Murney Tower**

#### **Operated by the Kingston Historical Society**



Two **summer students** were hired via the Young Canada Works and Canada Summer Jobs grant programs for May 11th to September 14th. Olivia Anstess and Emma Binns have worked as Museum Assistants. Young Canada Works is potentially going to extend their contracts for another 560 hours covering Fall 2020 and Winter 2021, allowing the museum to complete more exciting projects! We also have a third Museum Assistant joining the team in Fall/Winter, Amy Abraham. This assistant is funded by Canada Summer Jobs.

**New Museum Committee**: The Murney Tower Museum has now successfully recruited a full steering committee of engaged volunteers with backgrounds in museum studies, cultural heritage, education, finance, human resources, academia and the military. In the past, the museum mostly relied on one key volunteer serving as Director and this left the museum vulnerable to volunteer burnout and succession crises. The introduction of an active committee to help direct staff in the operation of the museum has helped spread out the workload, increased oversight and strengthened relations between the museum and its parent or-

ganization, The Kingston Historical Society. The team consists of Tabitha Renaud, Vincent Durant, Simge Erdogan, Don Richardson, Liz Watkins and Tanya Scott.

## Looking at Regional Architecture with Jennifer McKendry

**75-77 Princess Street:** "a convenient and elegant building" (excerpt from *Kingston, the Limestone City* by Jennifer McKendry, forthcoming)

Fortunately, this two-storey stone building has survived on the city's main street for just over 200

years. The street-level storey has been modified with commercial store fronts but the upper stonework is still in place. A cross-section from 1846 shows dormers on the front and back slopes of the roof but the present four (originally three) are recent additions. Described as new in 1817, John Moore rented Major Anderson's stone house and opened Moore's Coffee-House and hotel in this "large, convenient and elegant building" with a good yard and stables for horses and carriages (Kingston Chronicle, 28 Feb. 1817). In 1821, he added a wing containing 20 single spaces for travellers, as well as enlarging the stables, and renamed it Mansion House Hotel. In September 1826, the Royal Circus took place by paid admission "in rear of the Mansion" House Hotel" starting with six beautiful chargers demonstrating a grand military cavalcade and other feats of horsemanship, such as ten-year-old Master



and a whole company of flying vaulters mounting horses without the use of stirrups. Olympic feats by G. Blanchard in Greek costume were followed by the Haunted Tailor

or Billy Button's Journey to Brentford.

Moore died at age 50 in 1826 and his widow Sarah continued the business. Other tenants followed including a school in the rear part of the hotel. In 1830, Sergo Carmino operated



the hotel until his death in February 1842 at age 56. His widow continued but in October the hotel's furnishings from the 39 bedrooms plus dining rooms, parlours, kitchen, stoves, etc. were auctioned. In addition two excellent horses, their equipment, sleighs and a coach were listed to sell. William Godwin, the next proprietor, changed the name to the North American Hotel in the spring of 1843. This is a glimpse into the early history of a building better known to us as Vandervoort's Hardware.

#### Letters Patent in favour of John Counter, Assignee of Charles Tripp for improvements in Stoves

These Letters Patent obtained at Toronto on 28<sup>th</sup> August 1850 under the Great Seal of Canada West and witnessed by James Bruce, 8th Earl of Elgin and 12th Earl of Kincardine, KT, GCB, KSI, PC, Governor General of the Province of Canada (1847–1854), afford insight into the existence of the virtually unknown Iron Works and Foundry at Kingston called the Ontario Foundry operated under the proprietorship of Kingstonian, John Counter. Counter, a successful businessman and Mayor of Kingston at this time, had engaged Charles Tripp, a Citizen of the United States of America as his foreman in the Foundry operation where in the course of his work there, Tripp had developed a new patterned stove operating on a new principle that he had sought Counter to Patent as his Assignee. By this time, Counter had already invested upwards of one thousand pounds in the manufacture of stoves of a new pattern and on a new principle discovered and invented in his foundry by Charles Tripp. Unfortunately, when this document was found among the Upper Canada Land Grants in the mid 1970s, there were no drawings or illustrations of the new type of stove with the documentation, but surely such would had been submitted with the application for a Patent.

The Iron Works and Foundry at Kingston called the Ontario Foundry operated by John Counter sheds little, if any, documentation apart from reference in these Letters Patent. In October 1855, Counter could not meet a large mortgage payment, and his financial obligations forced him into bankruptcy such that his country house built in 1847 was taken over by a bank in 1856, the same year that his extensive holdings were disposed of by chancery sale. It was in 1855 that distillery, lumber yard, and ship builder industrialist, John Morton of Kingston, purchased the Ontario Foundry located at Mississauga Point on Kingston's waterfront and began to manufacture locomotives for the rapidly expanding Canadian railroad system. Geographer Osborne and historian Swainson observe that the early history of the firm is as murky as its achievements are impressive. How, when, or where Morton the miller-cum-machinist acquired his technological skills is unknown; but it is on record that in 1856 his Ontario Foundry delivered five locomotives to the Grand Trunk, but by 1864 Morton was bankrupt. 2

The first iron works in Upper Canada were established in 1801 on the eastern banks of the Gananoque River below the 7.3 metre falls of the village of Lyndhurst by Vermont founderer, Wallis Sunderlin. Now known as the Lansdowne Iron Works, a National Historic Site, where Sunderlin produced cast iron and forged wrought iron goods for area settlers until it was destroyed by fire in 1811 and Sunderlin dying in the War of 1812. In operation by 1840, the Kingston Foundry manufactured stationary and marine steam engines plus – at least in the late 1850s – sawmill machinery. Canada's oldest continuously operating foundry, Alloy Foundry Co. Ltd., of Merrickville has produced sand castings since its founding in 1840. James A. Smart's foundry operation dates from 1854, and by 1856 his Novelty Works were operating on Kincaid St. in Brockville. Counter's vigorous operation of the Ontario Foundry at Kingston by 1850 placed it in the vanguard of the earliest foundries. Nearly 40 years lapsed before other Ontario foundries were established, e.g., the Percival Plow and Stove Co. since 1887 in Merrickville; the Adam Hall foundry in Peterborough was manufacturing since 1887, and the Beach Foundry Ltd. was begun in Ottawa in 1894.

John Counter came to Kingston with his parents about 1820 from Devonshire, England. At first a baker and confectioner, he later expanded his commercial interests into transportation and real estate. His first recorded investment in Kingston was in August 1826 when he bought a £25 share in the Penny Cataraqui Bridge Company later to become the La Salle Causeway. In January 1836, Counter formed and was first chairman of the Kingston Stave Forwarding Company based on Garden Island. In April of the same year he also formed the Marine Railway Company for ship repair and shipbuilding starting it with his own capital the opening it up to public subscription expanding to include a sawmill, an iron foundry, extensive shops and wharfage rights. He was the first Mayor of the incorporated City of Kingston in 1846 and was elected again in 1850, 1852, 1853, and 1855. In 1842, as mayor, he went to England to borrow money so the town could erect a municipal building befitting the then capital of the province. With John A. Macdonald, he gave a clock for the tower of the new building, completed in 1844, which became the city hall when Kingston was

incorporated as a city in 1846. A strong supporter of the Wesleyan Methodists, Counter donated generously to the building fund for the Victoria Street chapel in 1847. He gave the land and laid the cornerstone, on 17<sup>th</sup> April 1851, for the Sydenham Street Church, and he served on its management committee. John Counter died 29<sup>th</sup> October 1862 at the home of his son-in-law at Kingston in virtual obscurity. Today he is remembered where his portrait hangs in the John Counter meeting room at Kingston City Hall, and more recently by the John Counter Boulevard, a major east-west arterial route that passes across the top of *Kingston* from the Cataraqui River to the western end of Princess Street.

Finally, the reader of these Letters Patent finds their dispatch by Robert Baldwinn\*, of Irish parentage<sup>5</sup>, Attorney General of the Province of Upper Canada, most unusual in making reference to the Right Well Beloved Cousin James Earl of Elgin and Kincardine Knight of the most ancient and Most Noble Order of the thistle Governor General of British North America and Captain General and Governor in Chief in and over Our Province of Canada, Nova Scotia, New Brunswick and the Island of Prince Edward and Vice Admiral of the same etc. \_\_\_etc.\_\_\_ etc\_\_\_. In fact, Robert Baldwinn could rightly claim James Bruce, 8th Earl of Elgin, and 12th Earl of Kincardine as his paternal 3<sup>rd</sup> cousin.<sup>6</sup> (GAN, 16 June 2020)

### **Province of Canada**

<u>Victoria</u> by the Grace of <u>God</u> of the United Kingdom of Great Britain and Ireland <u>Queen</u>

<u>Queen</u> Defender of the Faith etc\_\_\_etc

To all to whom these Presents shall come or whom the same may concern\_\_\_\_\_

Whereas by An Act of the Parliament of this Province passed in the Twelfth year of Our Reign, entitled "an Act to consolidate and amend the Laws of Patents for Inventions in this Province," it is amongst other things in effect enacted, That any person a Subject of Her Majesty and resident in this province, having discovered or invented any new and useful Art, Machine, Manufacture or Composition of Matter, or any new and useful improvements on any Art Machine, Manufacture or Composition of matter, or the principle thereof the same not being known or used in this Province by others, before his her or their discovery or invention thereof, and not at the time of the application for a Patent in public use or on Sale in this Province, with his consent or allowance as the inventor or discoverer thereof, and desiring to obtain an exclusive property therein, may make application, by Petition in the manner provided in and by certain Acts of Parliament therein recited, to the Governor or Person Administering the Government of this Province, expressing such desire and that the said Governor or Administrator on due proceedings being had as by the said Acts directed to be done shall grant such Patent which shall be good and available to the said Grantee his Heirs, lawful Representatives, or assigns, for the period of fourteen years from the granting of the same after the said Letters Patent shall have been recorded in the manner directed by the said Acts, and upon the assignment of the same previous to the grant aforesaid, for the same period after such assignment shall have been recorded in the Office of the Secretary of the Province. And whereas one John Counter by his Petition to the Legislature of this Province represented that he is the proprietor of the Iron Works and Foundry at Kingston called the Ontario Foundry and carries on business at such Foundry to a large extent that he has invested upwards of one thousand pounds in the manufacture of Stoves of a **New pattern** and on a **new principle discovered** and invented in this province by one Charles Tripp a Citizen of the United States of America employed by the said John Counter as his foreman in the said Foundry and that the said Charles Tripp has assigned to him the said John Counter all his interest in the said discovery or invention and is willing and desirous that he should obtain a Patent for the same - And whereas the said Charles Tripp not being Our Subject a certain Act of the Parliament of Our Province was thereupon passed by Our Provincial Parliament at their Session held in the thirteenth and fourteenth year of Our Reign entitled [p. 360] "An Act to enable John Counter to obtain a Patent for making Stoves of a new Pattern and on a new principle, whereby it is enacted, That for and notwithstanding anything in the said first inventions Act contained to the contrary it should and might be lawful for the Governor General of Our said Province if he should see fit to grant a Patent to the said John Counter for the new discovery or invention in the same manner and to the same effect as the same might have been granted to him under the said first mentioned Act if he had been the discoverer and Inventor of the said new Pattern and new principle which said new Invention or Discovery may be shortly described as follows, that is to say. The nature of the said Invention consists in the addition of flanges to the doors of the stoves by which means when closed they are rendered perfectly air tight – in the admission of cold air into air. Chambers on the sides and in the centre of the

Stove which coming in contact with the heated plates prevents their burning, and which, also, being at pleasure admitted into or excluded from the oven, regulates its heat or carries off vapours or steam from it into the main flue of the Stove – and in the mode of attaching a Summer arrangement to the front of the stove by means of which a damper which, when closed is the hansit for ashes from the main Stove to the ash Pit, when raised forms a flue from the Summer arrangement beneath the oven into the main pipe – and of which Invention or Discovery a full drawing description and Specification are to these Presents affixed and hereby made part of the same and Duplicates thereof are deposited in the Office of the Secretary of this Province according to the said Statute together with the said assignment from the said Charles Tripp to the said John Counter bearing date the sixth day of May last past and recorded in the Office of the Secretary of Our said Province on the eleventh day of August in the same year and whereas the said John Counter having applied to Our Governor General of Our said Province for Letters Patent in pursuance of the said Acts, and it being thought fit by Our said Governor General that such Letters Patent should be issued to the said John Counter accordingly - Now know Ye that We of Our especial grace, certain knowledge and mere motion Have given and granted and by these Presents for Us Our Heirs and Successors do give and grant unto the said John Counter his lawful Representatives and assigns and every of them by his and their Deputy or Deputies Servant or Servants, Agent or Agents or such others as he the said Patentee, his lawful Representatives and Assigns shall at any time agree with, and no others, from time to time and at all times hereafter, during the term of fourteen years herein expressed the full and exclusive right and liberty of making, constructing, using and vending to others to be used the said Invention or Discovery within Our Province of Canada in such manner as to him the said Patentee his lawful Representatives and assigns or any of them shall in his or their discretion seem meet, and that the said Patentee his lawful Representatives and assigns, shall and may have use and enjoy the whole profit, benefit, advantage and commodity from time to time accruing or arising, for or by reason of the said Invention or Discovery for and during the term of years herein mentioned To have and To hold receive and enjoy the said license, powers, privileges and advantages hereinbefore granted or intended to be granted unto the said Patentee his lawful Representatives and assigns for and during and unto the full end and term of fourteen years from the said Eleventh day of August in this present year/being the day on which [p. 361] such assignment was recorded in the office of the said Secretary of the Province as foresaid and fully to be complete and ended according to the Statutes in that case made and provided And to the end that the said Patentee his lawful Representatives and assigns, and every of them may the more effectually have and enjoy the full benefit and the sole use, exercises and enjoyment of the said Invention or Discovery as aforesaid, according to Our Gracious intention hereinbefore declared and in pursuance of the Statute in such case made and provided <u>We do</u> by these presents for <u>Us</u> Our Heirs and Successors require and strictly command all and every person or persons, bodies politic and corporate, and all our Subjects whomsoever, of what state, quality, name or condition soever they be, within Our said Province of Canada, that neither they, nor any of them, at any time during the continuance of the said term of fourteen years, hereby granted wither directly or indirectly, do make, use or put in practice the said Invention or Discovery or any part of the same, so attained unto and invented by the said Charles Trip as aforesaid nor in anywise counterfeit, mutate or resemble the same, nor make nor cause to be made any addition thereto or substraction [sic] therefrom these from whereby to pretend himself, herself or themselves the inventor or inventors, deviser [sic] or devisers [sic] thereof, without the licence [sic] consent or agreement of the said Patentee his lawful Representatives or assigns in writing under his or their hand first had and obtained in that behalf, upon such pains and penalties as can or may be justly inflicted on such offenders or offenders for their contempt of this Our Royal Command, and further to be answerable to the said Patentee his lawful Representatives and assigns, according to Law – and moreover We do by these Presents for Us Our Heirs and Successors will and command all and singular the Justices of the Peace, Sheriff, Bailiffs, Constables and other Officers and Ministers of Us Our Heirs and Successors for the time being, that they nor any of them do not nor shall at any time hereafter during the continuance of the said Term hereby granted, in anywise trouble or molest or hinder the said Patentee his lawful Representatives or assigns or any of them or his or their Deputies Servants or Agents or any of them in or about the due and lawful use, exercise and enjoyment of the said Invention or Discovery aforesaid or in or about any thing relating thereto **Provided always** that these Our Letters Patent and all liberties and advantages hereby granted shall utterly cease and determine and become null and void, if the said Drawing, Description and Specification do not contain the whole truth relative to the said Invention or Discovery or if such Drawing, Description and Specification contain more than is necessary to produce the desired effect such concealment or addition appearing to have been made to deceive the public or if the said Charles Tripp was not the first discoverer and inventor of the said Invention or Discovery in these Our Letters Patent mentioned, or if the same was known or in use in Our said Province, before the same was invented by the said Charles Tripp and before the application of the said John Counter for these Our Letters Patent in all and each of which cases these Our Letters Patent shall be and remain void.

#### **About the Author**


