

Rationale: There are two reasons for this amendment. First, the total number of members of Council as currently mandated, i.e. 16, is considered to be more than is essential, and can contribute to meetings being longer than necessary. Secondly, and more importantly, it is becoming increasingly difficult to draw volunteers to sit on Council. Assigning specific roles to those 12 who do so decide, streamlines Council, avoids the scenario just mentioned, and still permits us to continue the work of Council.

e) The Editor's Report, Limelight---2022

Limelight is the newsletter of the Kingston Historical Society, published in nine monthly issues from September to May. Allan Graphics is the printer used.

Fifty-two copies of *Limelight* are mailed each month, with other members receiving *Limelight* by email.

Featured monthly in *Limelight* are ads for the KHS sponsors, the message from the president, a Murney Tower entry, the announcement of the presenter for the next meeting, and the Program Chair's report on the presentation at the last meeting. Noted are new members, and deaths of members. There are articles, book reports and opinion pieces of local historical interest, as well as advertisement of recently published books by members and other local historians.

In 2022, Fellow Historians articles were written for the Leeds and 1000 Islands Historical Society, The Wolfe Island Historical Society, Friends of the Rideau, The Delta Mill Society, KAM, and, sadly, about the demise of the Pittsburgh Historical Society. Three articles appeared in Dr. Jennifer McKendry's *Still Standing: the Kingston Penitentiary, the Rocheleau House and the William Street Walking Tour*. Profiles are published of The Kingston Historical Society Award recipients.

Webmaster Peter Gower posts *Limelight* to the KHS website. Membership Chair Paul Van Nest proofreads each issue, posts the website link to those who receive *Limelight* by email, and supplies labels for mailing *Limelight* to members who receive a hard copy.

f) The Membership Report---2022

I want to acknowledge the appreciation of Council that so many have continued their membership despite our inability to meet in person. Some of you don't have the ability to participate in our monthly meetings on ZOOM, and yet you continue to support us with your memberships. Thank you.

Starting in January, we branched into the norm utilizing the "hybrid model" – a phrase most of us didn't know a year or two ago. We hope this will prove to be advantageous to our membership, giving us the ability to meet in person at a beautiful facility in the conference rooms of Kingsbridge Retirement Community and, simultaneously, the ability to deliver our programs to those who can't attend in person due to distance, mobility issues or weather.

We also welcomed 33 new members in 2022: 19 individuals, 4 families (assuming 2 persons) and 6 spouses of members (from individual to family status). We were, however, sorry to have lost 31 members: 8 individuals, 6 families, 2 students, 4 spouses of members, 1 life member, and 2 deaths. We also lost one institutional member and one sponsor.

g) The Murney Tower National Historic Site Committee Report---2022

Here at the Tower, we are very proud of the work we have done in 2022 to continue building capacity while modernizing and professionalizing our operations. We continue to secure grants for revitalization projects and to increase our staffing. Our manager/curator, Simge, will have full time hours for 2023. We also installed two new exhibits and introduced crafts and treasure hunts to our standard offerings. Simge has given many stellar print and television interviews. These efforts meant that we DOUBLED the number of visitors to the museum and saw ten thousand hits on our new website in 2022.

We did extensive collections management work in our off-site climate-controlled storage unit. Our team processed 700 artifacts to professional museum standards. We also established a Collections Committee, a joint initiative between the museum and the Kingston Historical Society, that will help govern its shared artifacts and archives. We are also updating the museum's collections policy.

We had many collaborations with community partners and offered new programming. We continue to expand our operations into the Fall and Winter. In September, the Tower presented as part of a prestigious historical lineup at the Kingston Fall Fair. We also saw 300 visitors tour the Tower for Doors Open 2022. In October, the Phantoms of Yore returned for another paranormal investigation. Tickets sold out quickly and the three-day event was a huge success that generated revenue for the museum.

This year we tried two brand new experiments that were successful. It is exciting to innovate and expand our offerings to be more active in our city year-round. In October we held a Halloween event called "Spooky Murney" in which visitors in costume participated in a brand-new spooky treasure hunt for prizes. In December, the Tower was opened during the winter for a holiday gathering called "Merry Murney." Visitors were able to participate in several crafting stations, decorate our tree and enjoy hot drinks and holiday treats. We had another themed treasure hunt that families loved, but many just wanted the novelty of entering the Tower in the winter. It is wonderful to decorate Murney for two holidays and allow the public inside during the off-season.

Simge and I created a professional audio tour for visitors that will especially help the visually impaired to experience the museum. This was an exciting new professional territory for us, and we had a lot of fun working on this project. This also allowed us to have accessibility consultants conduct a survey of the Tower to help us work towards meeting our accessibility goals. Overall, it has been another fantastic year at the Murney Tower, and we thank you for your support!

h) The Program Report---2022

In the continuing midst of the COVID pandemic, the Society perforce maintained its reliance upon Zoom presentation of its lecture series. Ably managed by our Zoom master, Paul Van Nest, the lectures were smoothly presented and later uploaded onto YouTube for wider distribution. While the arm's length nature of electronic lecturing deprived the Society of the intimacy and collegiality of in-person lecturing, it did allow the Society to reach out to a broader audience well outside the traditional constituency of its lectures. In the hope that COVID's immediate jeopardy is easing, the Society hopes to implement a continuing hybrid platform for its lecture series – simultaneous live and Zoom presentation from a lounge in Kingston's Kingsbridge Retirement Community beginning in January 2023.

j) The Sir John A. Macdonald June 6 Graveside Ceremony Committee Report---2022

The ceremony commemorating the death of Canada's first prime minister was, for the second year in a row, a video ZOOM event due to the COVID pandemic. However, it was a truly unique ceremony and as one of our members stated "a truly astonishing commemoration".

Our MC, Don Richardson, incorporated not only French and English but also Mohawk into his opening and closing remarks. Our national anthem, O! Canada, was an Indigenous version, which was in keeping with who our guest speaker was.

Our guest speaker, the Honourable Murray Sinclair, is a former member of the Canadian Senate and First Nations lawyer who served as Chairman of the Indian Residential Schools Truth and Reconciliation Commission from 2009 to 2015. He previously served as a judge in Manitoba from 1988 to 2009, being the first Indigenous judge appointed in the province and the second Canadian Indigenous judge. At present he is the Chancellor of Queen's University in Kingston.

Sinclair gave a very different view of Sir John and his legacy which we have titled "A slightly different light: a more complete image of Sir John A. Macdonald". It was a very balanced assessment which not only recognized the role that Sir John played in creating Canada and expanding Canada to the Pacific, "a man of great will, great ability, political acuity, and a willingness to undertake and achieve something quite significant" but also that he had his flaws. "We should also acknowledge that what he did to build this country was at great cost to the Indigenous people of Canada. He left us with a challenge in his closing remarks: "I hope that [my comments] help all of us in the process of reconciliation, to which I know we are all committed."

The success of this year's ZOOM presentation was due to the creative juices of many individuals. Firstly, our video recorder and editor, Craig Pettis was superb with his suggestions and editing. Don Richardson was sparkling as our MC and in an innovative move decided to incorporate our Indigenous heritage into his remarks and as such broke new ground. Duncan McDowall was spot on with his suggestion and encouragement to have Murray Sinclair as our guest speaker. We are indebted to Paul Van Nest for his suggestions and guidance with his video technological knowledge. Our thanks to Tabitha Renaud and the Murney Tower for their financial grant assistance. The Cataraqui Cemetery staff assisted us, as in the past, with on-site preparations at Sir John's grave site. Eva Barnes' assessment of the video has been most helpful.

The ZOOM video may be accessed at the Kingston Historical Society website https://www.kingstonhistoricalsociety.ca/events-news/ and scroll down to 2022 and **Murray Sinclair and the Sir John A Macdonald memorial service.** Please note there is a 5-minute musical intro before the actual memorial commences.

Hopefully next year we shall have a live commemoration at Sir John's grave site in the Cataraqui Cemetery.

8. The Treasurer's Report---2022

In 2022 the Society began to settle into a new normal of activities. The continued use of ZOOM for monthly presentations and a virtual commemoration ceremony of Sir John A's passing on June 6th reduced normal costs from pre-pandemic levels. The generosity of members through donations contributed significantly to the Society's solid financial yearend. The General Fund had a significant operating surplus in 2022 and had bank deposits and investments of over \$105,000 at year end.

The Murney Tower Museum was able to welcome in-person visits on a reduced opening schedule for a portion of 2022. Admission was "by donation" but revenues were not far off pre-pandemic levels. In addition, special events generated funds.

Thanks to grants from the federal government and the City of Kingston's Heritage fund, the staff required to operate the Tower Museum and related activities were funded without dipping into reserves. Additional grants from the Community Foundation and Regional Tourism covered the costs of special initiatives. The Tower has ended the year with an operating surplus and has more than \$100,000 in bank deposits and investments. From these funds, an "Internally Restricted Contingency Reserve" has been established to protect against a shortfall in future grants.

The overall financial position is set out in more detail in the Financial Statements prepared by the staff of Secker, Ross & Perry.

Doug Petty was designated to review the 2022 financial records for the Society at year-end. His report is contained below.

- 1. The conduct of the affairs of the Society shall be entrusted to a Council constituted as follows:
- (a) Five Executive Officers, namely the

President,
Vice-president,
Secretary,
Treasurer,
Immediate Past-president, and

(b) 5 or 6 elected councillors.

Elected Terms

The President and Vice-president shall serve two-year terms. The remainder of the councillors shall serve one-year terms, either acclaimed or elected at the AGM. The immediate Past-president shall serve until replaced by a president leaving her/his role.

There shall also be 3 appointed councillors, namely the Chair of the Murney Tower Committee, the editor of *Historic Kingston*, and the editor of *Limelight*. These councillors will be appointed at the first Council meeting following the AGM and will have the same constitutional rights as the elected councillors.

These positions may also be filled by elected councillors.
