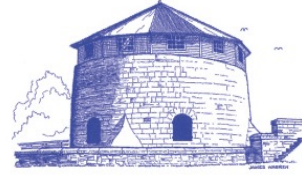

### **PROPOSED AMENDMENT**

Motion to amend the constitution as follows:

#### **Constitution Part A**

#### **Section III, Council**

1. The conduct of the affairs of the Society shall be entrusted to a Council constituted as follows:

(a) Five Executive Officers, namely the

President,  
Vice-president,  
Secretary,  
Treasurer,  
Immediate Past-president, and

(b) 5 or 6 elected councillors.

Elected Terms

The President and Vice-president shall serve two-year terms. The remainder of the councillors shall serve one-year terms, either acclaimed or elected at the AGM. The immediate Past-president shall serve until replaced by a president leaving her/his role.

There shall also be 3 appointed councillors, namely the Chair of the Murney Tower Committee, the editor of *Historic Kingston*, and the editor of *Limelight*. These councillors will be appointed at the first Council meeting following the AGM and will have the same constitutional rights as the elected councillors.

These positions may also be filled by elected councillors.

### **e) The Editor's Report, *Limelight*---2023**

*Limelight* is the newsletter of the Kingston Historical society, published in nine monthly issues from September to May. Allan Graphics is the printer. Forty copies of *Limelight* were mailed each month, with the other members receiving *Limelight* by email.

Featured monthly in *Limelight* were ads for the KHS sponsors, notifications of deaths of members, a welcome to new members, a message from President Paul Charbonneau, the report on the month's speaker by program Chair Dr. Duncan McDowall, the announcement of the presenter for the next meeting and a Murney Tower activity update.

This year, Dr. Jennifer McKendry's *Still Standing* column featured the Empire Life building, Christ Church, Cataraqui, and Stone Gables.

Articles, book reports and opinion pieces of local historical interest appeared, as well as mention of recently-published books by members and other local historians.

A new column, *Ear to the Ground* by Elizabeth Durno, reporting on events of interest to history buffs, was begun in 2023.

A profile of Dr. Tabitha Renaud as the Kingston Historical Society Award recipient for 2022 was published. The heritage event in February and the June 6 gathering commemorating Sir John A. Macdonald received coverage. Webmaster Peter Gower posts *Limelight* to the KHS website. Membership Chair Paul Van Nest proofreads each issue, and posts the website link to those members who receive a hard copy.

### **f) The KHS High School Awards Report---2023**

In the Fall of 2022, Council considered new ventures that could best utilize the capital we have accumulated over the years. One was a history award given to a grade 12 graduating student for each of the 9 area high schools. Paul Van Nest volunteered to undertake the leg-work to develop a proposal, in collaboration with the Limestone District School Board as a starting point. Corinna Dupuis, Head of Student Services at Loyalist Secondary School, and he developed the wording below, avoiding reference to grades at her suggestion as the award could not nor should be based solely on marks. Paul felt strongly that senior history teacher(s) were to have a significant input in the selection process. Council felt that the Society could commit \$1500 a year towards this legacy project into the foreseeable future. There being 9 secondary schools in Kingston we determined, again in consultation with the schools, that a \$150 subject award was appropriate and would be well received by a graduating student. No such award existed in any of these schools, and so Council committed to making this an annual award on behalf of the Society.

In the midst of making these decisions, Corinna, Don Richardson (KHS Secretary) and Paul then began the hard work of recommending the criteria. After many iterations from

consultations with history teachers and heads of student services, the following wording was accepted:

*This award is presented to a graduating student in each of the nine City of Kingston Secondary Schools who has shown an aptitude and passion for history in any of its many forms. As performance in grade 12-level Canadian and/or world history course(s) will be a factor, the student's teachers will have input into the selection of the successful recipient. The criteria may also include the candidate's intention of pursuing further education in the humanities and/or social sciences. By history, we include its many forms, such as archaeology, anthropology, cultural heritage, social history, museums, etc.*

## g) The Membership Report---2023

Our lives have been changed in an existential way, thanks to COVID; we've learned how to use ZOOM! And, believe it or not, some don't want to lose the advantages. Our technical person, Paul Van Nest, has grown his skills from providing our programs in ZOOM-only to what is called "hybrid" mode: both in-person and online in real time. We can thank the facility hosting us, Kingsbridge Retirement Community, for providing its social and technical facilities at no charge. So, this is our new norm, and we are getting used to it. What your membership Chair doesn't understand is why this has not increased our membership. It has, on the other hand I think, increased our attendance, including those online, at our meetings. It has, of course, enabled those members from afar to attend.

We were pleased to welcome 20 new members this year, but overall, we have lost 15 members. Surprisingly, family memberships dropped considerably this year, in part due to ten converting from family memberships to personal memberships (only one spouse being a member); only four went the other way. Four members died this year: Bob Cardwell, Eleanor Einarson, Frank Milledge and Britton Smith.

We are pleased to welcome two new sponsors this year: Kingsbridge Retirement Community (our host) and Secker, Ross & Perry, our accounting firm. As well, we appreciate the support of our ongoing sponsors, year after year.

We hope to increase the number of student members (fee \$10) this coming year by reaching out to Queen's students and, as in the past, enlisting a few to speak to us on their research projects.

We promote our monthly programs through press releases sent by our Publicity Chair, Past-president Vincent Durant. However, our best promotion rests with all of you; please, invite your friends to join us as guests for a program or two, in person or online. If online, either send them the link that I send you or, better, send their email address to me and I

will forward the link to them along with some information about our Society. Thank you for your help.

#### **h) The Murney Tower National Historic Site Committee Report---2023**

- The Murney Tower Museum had a very memorable and successful year. The museum welcomed 12,600 visitors between May and September and had approximately 1,000 special event participants who participated in the museum's special events and educational activities.
- One of the highlights of 2023 was our audio tour project, which was developed in collaboration with accessibility experts, consultants, and representatives to address the needs of individuals living with disabilities, and improve their access to Kingston's cultural spaces. Between May and October 2023, the audio tour was used by more than 300 people and received a satisfaction rate of 97%. In November 2023, we completed the French version of the audio tour which is now available on the museum's website.
- 2023 also saw the organization of new holiday-themed events and off-season activities, which engaged more than 600 people with the unique history of the museum and provided them with an opportunity to experience the Murney Tower in a different way. This year we organized an Easter event, Halloween event and Holiday event, all in collaboration with the Museum of Healthcare at Kingston.
- In 2023, the museum participated in three collaborative community events. The first one took place in March when we participated in the March of the Museums event and engaged with 600 people. The second one took place on May 8<sup>th</sup>. The museum had a booth at the Heritage Fair and engaged with 200 students. The last community event took place in August. We participated in the Princess Street Promenade event and engaged with 170 people.
- In 2023, we received a \$12,000 grant from the Community Services Recovery Fund and started developing an app and a game for the museum. I have been working with a game developer named Carson Mark, who developed a matching game for the museum (available on Apple Store). I also purchased an iPad Pro 12 inch and iPad stand for onsite experience. The project is currently in its second stage. Carson will develop the French version of the game, add sound effects, and further develop the app for the 2024 season.
- In 2023, I redesigned all informative panels and exhibits and got them professionally translated into French. The biggest advancement has been the addition of informative panels to the basement, which used to be empty. Seven panels have professionally been printed on a durable material.



- In 2023, we bought two new display cases to modernize the exhibits: a gun case and a case for the Parks Canada display. I also bought display materials such as display bridges and supports to improve the quality of displays. I also created four new displays, two for the barracks level and two for the gun platform.
- In 2023, the museum received four donations: two military medals, an account book, and an original key to one of the storage rooms of the basement. The medals and account book were put on display.
- In 2023, we de-accessioned the Rob Collection. Approximately 200 items were retransferred to the Museum of Archaeology of the University of Western Ontario.
- In 2023, we participated in Tourism Kingston's brochure-racking program and the K-PASS program.
- In 2023, I conducted two classroom visits and delivered a travelling collection workshop and gave five off-season tours.
- In 2023, we launched the first edition of our annual event, the Murney Fest. The first edition took place in late July and had 200 people. We offered a yoga session, oil painting activity, and late admission.
- We received three positions from the Young Canada Works and Canada Summer Jobs and got all summer positions funded in 2023.
- In 2023, we had two interns through the HIST 212 Experiential Learning Course.
- In 2023, I joined two Tourism Kingston committees: the Attractions Committee and Visual Creators Committee. I have been attending their meetings, which take place four times a year.
- In September 2023, I started working on the museum's 100<sup>th</sup> anniversary celebrations. I formed a 100<sup>th</sup> anniversary planning committee which consists of Anne Richardson (KHS), Peter Radley (KHS), Sam Nicholls (former employee), Baraa Abuzayed (museum volunteer), Ashley Bradshaw (Tourism Kingston) and Tamara Van Dyk (Bellevue House/Parks Canada). The committee will work over the course of 1.5 years with the museum staff on the planning of 100<sup>th</sup> anniversary events and projects. The first meeting will be held in January.
- In February 2023, I gave a guest lecture on the history of the Murney Tower at the Brockville Art Museum. In August 2023, I led a professional development workshop offered by KAM and discussed our accessibility initiatives. In April 2023, I will be a panelist at the Canadian Museum Association Conference and will discuss our audio tour project.

### i) **The Program Report---2023**

After two COVID years of presenting its lectures on ZOOM and subsequently via YouTube, the Society in 2023 adopted a hybrid approach to its lecture program: live lectures presented in the spacious and well-appointed theatre lounge of the Kingsbridge Retirement Community at 950 Centennial Drive off Princess Street, and simultaneously offered via Zoom. Kingsbridge residents also freely attended the lectures. All lectures were presented at 7:00pm on the third Wednesday of each month. On the whole, the lectures' audiences split between live attendance and ZOOM viewership with an average of about 35 people. KHS lectures are subsequently posted on YouTube. Special thanks are extended to Paul Van Nest and Craig Pettis for their masterful handling of the technical oversight of the lecture presentations.

The Society is most grateful to the Kingsbridge Retirement Community for its gracious hospitality in hosting our lectures.

**January 18, 2023:** **James Reid** and **Sarah Hedberg** provided an overview of the history of James Reid Funeral Home and its place in Kingston business and society since its founding in 1854.

**February 20, 2023:** In collaboration with the Frontenac Heritage Foundation, we celebrated Kingston's Heritage Month. The event centred around the book launch and subsequent lecture of **Dr. Robert Banks'** upcoming *Warriors and Warships: Conflict on the Great Lakes and the Legacy of Point Frederick* (Dundurn). Dr. Banks' lecture focused on the research and writing of the book and his personal perspectives on Kingston heritage. This was an afternoon event at Memorial Hall in City Hall accompanied by afternoon tea.

**March 15, 2023:** Military historian **Dr. Matthew Barrett** discussed his ground-breaking use of graphic art – cartooning – to convey historical narrative and analysis. Barrett's pictorial chronicle of events such as the battle for Hill 70 in World War I has been widely featured in the national press.

**April 19, 2023:** **John Grenville**, former Curator and Historical Research Officer at Fort Henry and long-time investigator of Kingston's military architecture reported on his research into the city's iconic Market Battery.

**May 17, 2023:** **Graeme Roy**, a docent and board member of the Railway Museum of Eastern Ontario, gave us an intimate glimpse of how the telegraph connected Canadians in the early years of Confederation. He reinforced his lecture with a demonstration of telegraphic equipment brought from his extensive collection at the Smiths Falls museum.

**June 6, 2023:** **Dr. Duncan McDowall** spoke at the annual graveside service commemorating Sir John A. Macdonald on a theme of Sir John's ongoing relevance in Canadian heritage.

**September 18, 2023:** Despite their proximity to Kingston, Wolfe Islanders have long prided themselves on the distinctiveness of their island culture. Professor **Anastasia Riehl**, a linguist at Queen's, reported on her research into the distinctive linguistic patterns that have evolved on Wolfe Island over many years.

**October 18, 2023:** To celebrate the arrival in Kingston Harbour of the *S.S. Keewatin*, the new museum ship of the Museum of the Great Lakes, **Chris West**, the board chair of the Museum, gave a talk on the procurement of the ship, its distinguished heritage and its potential for Kingston tourism.

**November 15, 2023:** Queen's doctoral candidate **Kaitlyn MacDonald's** research into what is called "dark tourism" (e.g. haunted walks, cemetery history) delved beyond the superficial into the historical construction behind our fascination with the abnormal and suggest ways in which such analysis may be used to enhance both our historical understanding and tourism management.

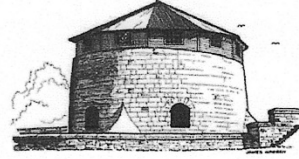
